

# Optional Services Switching U.S.A. CN 9001 US – H Effective July 1, 2014



### **Switching on request**

Whenever we undertake a move for you, we provide the switching services necessary to position railcars for you. These services — included as part of your linehaul shipment — provide for the initial pick-up and delivery of railcars at your plant.

Our objective in designing these services is to provide you with options, while optimizing asset utilization and availability, all with the goal of making it very efficient — and just as importantly, easy for you to do business with us.

#### Optional switching services

If in addition to the switching services we provide you as part of your linehaul shipment — you require cars to be moved between industries in a switching district, or to another railroad within a switching district, we can provide the services you need.

Please note that fees are based on handling loaded cars in one direction and empty cars in the other direction. If a car is loaded in both directions, the switching fee will be applied to both moves. Intra-plant switching services are described in tariff CN 9000.

"Switching within a district" is the terminology used for two types of switches:

- between a point on CN's line to another point on CN's line within a switching district (intra-terminal switch)
- between a point on CN's line to a point on another railroad's line within a switching district (inter-terminal switch)

When we perform an inter-terminal switch for you, your total fee for the service is our switch fee (below) plus the connecting carrier's switch fee. The switching rates listed below are not applicable on shipments of dimensional loads, dangerous/hazardous materials or on shipments of PIH/TIH products. CN requires a full Bill of Lading (EDI 404 or Shipping Instructions from CN's eBusiness site) for all local switching movements.

# Switching to/from interchange connections with other rail carriers

We provide switching services for pick-up and delivery of railcars between your facility and interchange locations where we provide connection to another rail carrier.

The other rail carrier provides you with the linehaul service, and compensates us for our switching services. However, for any of the additional services detailed below that we are requested to perform, certain fees are assessed.

#### Connecting Rail Carrier Interchange

When insufficient information is provided to CN to properly continue the movement of a railcar received in interchange, we will assess the following fees to the connecting carrier.

CARRIER: INTERMEDIATE CARRIER'S SWITCH CHARGE	Item 2000
Except as otherwise provided, when the interchange between CN and the linehaul carrier is effected by an intermediate carrier, applicable tariff charges assessed by the intermediate carrier for the switch movement of a loaded freight car from or to the connecting linehaul carrier or for the return of an empty car to the linehaul carrier will be in addition to the CN Reciprocal Switching Charge.	

CARRIER: INTERMEDIATE ERROR MOVEMENTS	Item 3000
Interchange error  If we receive loaded or empty cars in error or without forwarding instructions from the delivering carrier, the cars will be returned to the delivering carrier or forwarded to the correct connecting carrier within the same switching district.  When railcars received in interchange are returned for mechanical or safety reasons, CN will assess the same charge as an interchange error movement.	\$520 per car (UP only) \$500 per car (IORY Only) \$435 per car (all other rail carriers) Responsibility: delivering carrier
Cars delivered without shipper information  Cars delivered by a switch carrier for a subsequent revenue move with CN, either in connection with a switch or when CN is the delivering carrier, must be accompanied by supporting shipper information.  If cars are delivered without this documentation, fees will be applied beginning two hours following the request for documentation to the delivering carrier, and continue until the documentation is received.	\$100 per car plus \$20 for each 24-hour period Responsibility: delivering carrier



The switching rates listed under CN 9001-US are not applicable on shipments of dimensional loads, dangerous/hazardous materials or TIH/PIH shipments. CN requires a full Bill of Lading (EDI 404, EDI 417, or Shipping Instructions from CN's eBusiness site) for such movements with CN showing in the routing.

(AC), Sault Ste. Marie Bridge Company (SSAM), Fox Valley & Western Ltd (FVW), Wisconsin Chicago Link (WCCL), The Pittsburgh & Conneaut Dock Company, BC Rail Partnership (BCOL), Duluth, Missabe and Iron Range Railway Company (DMIR), Bessemer and Lake Erie Railroad Company (BLE), Elgin, Joliet and Eastern Railway Company (EJE) and these companies doing business under the name of and collectively referred to as CN.

**Currency**: All charges are assessed in the currency of the country in which the chargeable event occurs unless specifically published.

**Standard Carrier Liability** will apply, except as specified in individual tariffs and contracts. This includes publications such as siding agreements, storage tariffs, etc.

**Station List**: This tariff is governed by the "OFFICIAL LIST OF OPEN AND PREPAY STATIONS," OPSL 6000 series.
