### **CN Supplier Registration**

#### Introduction

To charge fees to CN you will need to create and maintain user accounts for your employees in the Fieldglass application. The following document will show you how to register as a CN Supplier.

### Accept the Supplier Invitation to Fieldglass

#### 1. Section Overview

The Fieldglass System Administrator will be responsible for the system management, configuration, user creation and maintenance.

### 2. Registering in Fieldglass

When the CN administrator adds you as a new Fieldglass supplier administrator in the Fieldglass application, you will receive a Supplier Invitation email containing a link to the Fieldglass registration page.

To register and create your Fieldglass supplier administrator account:

1. Click the link in the email you received.

You will be directed to the Fieldglass Registration website.

2. On the welcome page you will be asked if you would like to link to an existing company in the Fieldglass system.

Select **No** if you currently do not have a Fieldglass account.

Select **Yes**, if you currently have a Fieldglass account and want to link all your accounts.

#### 3. Click Continue.
