CN declares second-quarter 2015 dividend

MEMPHIS, Tenn., April 20, 2015 — CN (TSX: CNR) (NYSE: CNI) announced today that its Board of Directors has approved a second-quarter 2015 dividend on the Company's common shares outstanding. A quarterly dividend of thirty-one-and-one-quarter cents (C\$0.3125) per common share will be paid on June 30, 2015, to shareholders of record at the close of business on June 9, 2015.

CN is a true backbone of the economy, transporting more than C\$250 billion worth of goods annually for a wide range of business sectors, ranging from resource products to manufactured products to consumer goods, across a rail network spanning Canada and mid-America.
