CN declares third-quarter 2017 dividend

MONTREAL, July 25, 2017 — CN (TSX: CNR) (NYSE: CNI) announced today that its Board of Directors has approved a third-quarter 2017 dividend on the Company's common shares outstanding. A quarterly dividend of forty-one-and-one-quarter cents (C\$0.4125) per common share will be paid on Sept. 29, 2017, to shareholders of record at the close of business on Sept. 8, 2017.

CN is a true backbone of the economy whose team of approximately 23,000 railroaders transports more than C\$250 billion worth of goods annually for a wide range of business sectors, ranging from resource products to manufactured products to consumer goods, across a rail network of approximately 20,000 route-miles spanning Canada and mid-America.
